TRAFFIC LANE - TOW ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Away Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD TOW ZONES:

- 28 W. 14th Place; W. 14th Place (south side) from S. California Boulevard to S. Fairfield Avenue; No Parking Tow Zone, all days, all times -- (14-00422781) [02013-6331]
- 36 W. Belmont Avenue; W. Belmont Avenue (north side) from a point 40 feet east of N. Neva Avenue to a point 40 feet east thereof; No Parking Tow Zone, all times, all days - (14-00425143) [02013-6407]
- 36 N. Oak Park Avenue; N. Oak Park Avenue (east side) from W. Grand Avenue to the first alley north thereof; No Parking Tow Zone - (14-00432275) [02013-6420]
- 41 W. Higgins Street; W. Higgins Street (north side) from a point 40 feet east to a point 40 feet west of N. Sayre Avenue; No Parking Tow Zone, all times, all days, also add; W. Higgins Street (south side) from a point 40 feet east to a point 40 feet west of N. Sayre Avenue; No Parking Tow Zone, all times, all days - (14-0050039) [02013-8967]

WARD AMEND TOW ZONES:

- 27 200-500 N. Western Avenue; Repeal Ordinance passed 4/16/52, journal page 2241, which reads: N. Western Avenue and S. Western Avenue (both sides) from N. Lake Street to S. Van Buren Street; No Parking Tow Zone, 7:00am to 9:00am and 4:00pm to 6:00pm, Monday through Friday, by striking the above -- (14-00405344) [02013-9504]
- 27 2100 W. Adams Street; Amend ordinance passed 12/1/52, journal page 3462, which reads: W. Adams Street (north side) from S. Halsted Street to S. Campbell Street; No Parking Tow Zone, 4:00pm to 6:00pm, Monday through Friday, by striking W. Adams Street from S. Hoyne Avenue to S. Leavitt Street; No Parking Tow Zone, 4:00pm to 6:00pm, Monday through Friday - (14-00611872) [02014-3411]
- 27 2100 W. Adams Street; Repeal ordinance passed 4/18/12, journal page 23806, which reads: W. Adams Street (north side) from S. Hoyne Avenue to S. Leavitt Street, No Parking Tow Zone, by striking the above - (14-00611741) [02014-3413]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
