West 35th Street; a line 97 feet east of and parallel to South Wood Street; the public alley next south of and parallel to West 35 th Street; and South Wood Street

to those of B2-1 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area described above.

Section 2. This ordinance shall be in force and effect from and after its passage and due publication.
