### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 6-F in the area bounded by

A perpendicular line to South Shields Avenue 169 feet north of and parallel to West 30<sup>th</sup> Street; the public alley next east of and parallel to South Shields Avenue; a perpendicular line to South Shields 144 feet north of and parallel to West 30<sup>th</sup> Street; South Shields Avenue,

to those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

**SECTION VII - ACKNOWLEDGMENTS, CONTRACT INCORPORATION, COMPLIANCE, PENALTIES, DISCLOSURE**
