Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CORNER BAKERY CAFE, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Awning(s) projecting over the public right-of-way adjacent to its premises known as 35 E. Monroe St..

• Said Awning(s) at S. Wabash Avenue measure(s):

One (1) at fifty-three (53) feet in length, and one (1) foot in width for a total of fifty-three (53) square feet. ' Said

Awning(s) at E. Monroe Street measure(s):

One (1) at sixty-four point six (64.6) feet in length, and three (3) feet in width for a total of one hundred ninety-three ', point eight (193.8) square feet.

; The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and i Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - • Signs.

j This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required [provisions of the Municipal Code of Chicago.

iThe grantee shall pay to the City of Chicago as compensation for the privilege #1113213 herein granted the sum of [one hundred sixty-seven dollars and sixty cents (\$167.60) per annum in advance. Ia 25% penalty will be added for payments received after due date.

[The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
