ORDINANCE  
100 EAST HURON STREET CONDOMINIUM ASSOCIATION Acct. No.  
68623 -1 Permit No. 1113632

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to 100 EAST HURON STREET CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Sundeck projecting over the public right-of-way adjacent to its premises known as 100 E. Huron St..

Said Sundeck at N. Rush Street measure(s):

One (1) at eighty-one point six seven (81.67) feet in length, and three point six seven (3.67) feet in width for a total of two hundred ninety-nine point seven three (299.73) square feet. Existing sundeck projection is located on the ninth (9<sup>th</sup>) floor level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1113632 herein granted the sum of one thousand three hundred forty-two (\$1,342.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
