ORDINANCE 1K Fulton, LLC Acct. No. 383089 -1 Permit

No. 1112501

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 1K Fulton, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use thirty (30) Bicycle Rack(s) on the public right-of-way adjacent to its premises known as 1000 W. Fulton Market.

Said Bicycle Rack(s) at N. Morgan Street measure(s):

Two (2) at point four two (.42) feet in length, and point three three (.33) feet in width for a total of point two eight (.28) square feet. Said bike racks shall be two (2) feet ten (10) inches in height.

iSaid Bicycle Rack(s) at N. Carpenter Street measure(s):

j Four (4) at point four two (.42) feet in length, and point three three (.33) feet in width for a total of point five five ' (.55) square feet. Said bike racks shall be two (2) feet ten (10) inches in height.

Said Bicycle Rack(s) at W. Fulton Market measure(s):

Seven (7) at point four two (.42) feet in length, and point three three (.33) feet in width for a total of point nine seven (.97) square feet. Said bike racks shall be two (2) feet ten (10) inches in height.

Said Bicycle Rack(s) at W. Carroll Avenue measure(s):

Seventeen (17) at point four two (.42) feet in length, and point three three (.33) feet in width for a total of two point three six (2.36) square feet. Said bike racks shall be two (2) feet ten (10) inches in height.

, The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of . Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1112501 herein granted the sum of , zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
