Permission and authority are hereby given and granted to HISTORIC STAND, LP HOLSTEN REAL ESTATE DEVELOPMENT CORP, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 6315 S. ; Cottage Grove Ave..
