ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the CI-1 Neighborhood Commercial District symbols and indications as shown on Map No.1-G in the area bounded by

West Fulton Market; a line 40 feet west of and parallel to North Aberdeen Street; a line 100 feet south of and parallel to West Fulton Market; and a line 80 feet west of and parallel to North Aberdeen Street,

to those of a CI-5 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
