ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS2 Residential Single Unit (Detached House) District symbols and indications as shown on Map No. 9-J in area bound by

North Monticello Avenue, a line 248.86 feet North of and parallel to West George Street, the alley next East of and parallel to North Monticello Avenue, a line 198.86 feet North of and parallel to West George Street

to those of a RM5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
