**A line 310.08 feet South of and parallel to West 43rd Street; South Langley Avenue; a line 329.83**

**South of and parallel to West 43rd Street; the public alley next West of and parallel to South**

**Langley Avenue.**

**To those of an RM4.5, Residential Multi-Unit District**
