ORDINANCE DIGITAL  
LAKESIDE, LLC Acct. No. 329127  
-1 Permit No. 1114625

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to DIGITAL LAKESIDE, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Covered Bridge projecting over the public right-of-way adjacent to its premises known as 350 E. Cermak Rd..

Said Covered Bridge at S. Calumet Avenue measure(s):

One (1) at sixty-six (66) feet in length, and twelve (12) feet in width for a total of seven hundred ninety-two (792) square feet. Existing covered bridge is over and across South Calumet Avenue approximately one hundred fifty-seven (157) feet south of the south line of East 21<sup>st</sup> Street and connect the Calumet Plant building with the West Plant building: the lowest portion of existing covered bridge is to be no less than eighteen (18) feet above street grade and the height and clearance destination is to be illuminated at all times.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1114625 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. Authority herein given and granted for a period of
