### RESIDENTIAL PERMIT PARKING ZONES

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1. Pursuant to Title 9, Chapter 64, Section 090, of the Municipal Code of Chicago, portions of the below named streets are hereby designated as Residential Permit Parking Zones, for the following locations:**

#### WARD RESIDENTIAL PERMIT PARKING ZONES:

- 8 S. East End Avenue; 7900-7999 S. East End Avenue (east and west sides); Residential Permit Parking Zone 1785, all times, all days [Or2014-374]
- 23 S. Kilbourn Avenue; Residential Permit Parking Zone, S. Kilbourn Avenue from 5400-5448 S. Kilbourn Avenue (east and west sides); Residential Permit Parking Zone 1791, all times, all days [Or2014-387]
- 23 S. Neenah Avenue; S. Neenah Avenue from 5514-5557 S. Neenah Avenue (east and west sides), Residential Permit Parking Zone 1790, all times, all days [Or2014-388]
- 31 5100 W. Deming Place; 5101-5143 and 5108-5144 W. Deming Place from N. Leclaire Avenue to the first alley east of N. Laramie Avenue (east and west sides); Residential Permit Parking Zone 1786, all times, all days [02014-6735]

**WARD            AMEND RESIDENTIAL PERMIT PARKING ZONES:**

- 23            W. 54th Street; Amend Residential Permit Parking Zone 1789 for 5300-5399 W. 54th Street from S. Neva Avenue to S. Nottingham Avenue, all times, all days, by striking 5300-5399 W. 54th Street and inserting in lieu thereof: W. 54th Street between S. Nottingham Avenue and S. Neva Avenue; Residential Permit Parking Zone 1789, all times, all days [Or2014-310]
- 25            1805 W. 23rd Street; Amend Residential Permit Parking Zone 109 to include: 1805 W. 23rd Street, as a Buffer Zone; Residential Permit Parking Zone 109 [02014-5896]
- 25            W. 22nd Place; Amend Residential Permit Parking Zone 109 for 2000-2059 W. 22nd Place (north and south sides); and 2100-2110 W. 22nd Place (north side); and 2101-2125 W. 22nd Place (south side); and 2137-2159 W. 22nd Place (south side); and 2124-2158 W. 22nd Place (north side); Residential Permit Parking Zone 109, all times, all days, by striking all times, all days, and inserting in lieu thereof: Residential Permit Parking Zone 109, 4:00pm to 7:00am, all days [02014-5907]
- 29            5903-5931 W. West End Avenue; Amend Residential Permit Parking Zone 149 for 5903-5931 W. West End Avenue (north and south sides), all times, all days, by striking 5903-5931 W. West End Avenue and inserting in lieu thereof: 5903-5961 W. West End Avenue; Residential Permit Parking Zone 149, all times, all days [Or2014-306]

**WARD            AMEND RESIDENTIAL PERMIT PARKING ZONES CONT'D:**

- 33            N. Bernard Street; 4559 N. Bernard Street; Amend Residential Permit Parking Zone 326 to include: 4559 N. Bernard Street; Residential Permit Parking Zone 326 [Or2014-406]
