### **ORDINANCE**

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 8-E in area bound by

South Prairie Avenue, a line 711.12 feet South of and parallel to East 33<sup>rd</sup> Street, the alley next East of and parallel to South Prairie Street, a line 743.16 feet South of and parallel to East 33<sup>rd</sup> Street.

To those of RT-4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
