ORDINANCE

BE IT ORDAINED BY THE CITY OF CHICAGO CITY COUNCIL:

SECTION 1. A new Chapter 9-100-160 is hereby added to the Municipal Code of the City of Chicago as follows:

9-100-160 Review and sunset.

Chapter 9-100-160 of the City of Chicago Municipal Code shall be subject to public review by the city council, to be concluded by October of 2017, and, unless otherwise authorized by the city council, shall expire on December 31,2017, thus allowing the city sufficient time to replace the revenue generated as the result of fines levied through enforcement of the provisions of this chapter.

SECTION 2. A new Chapter 9-101-070 is hereby added to the Municipal Code of the City of Chicago as follows:

9-101-070 Review and sunset.

Chapter 9-101-070 of the City of Chicago Municipal Code shall be subject to public review by the city council, to be concluded by October of 2017, and shall, unless otherwise authorized by the city council, expire on December 31,2017, thus allowing the city sufficient time to remove all equipment utilized in the automated speed enforcement program and replace the revenue generated as the result of fines levied through the enforcement of this chapter.

SECTION 3. A new Chapter 9-102-050 is hereby added to the Municipal Code of the City of Chicago as follows:

9-102-050 Review and sunset.

Chapter 9-102-050 of the City of Chicago Municipal Code shall be subject to public review by the city council, to be concluded by October of 2017, and, unless otherwise authorized by the city council, shall expire on December 31, 2017, thus allowing the city sufficient to time to remove all equipment utilized in automated traffic law enforcement system and replace the revenue generated as the result of fines levied

through the enforcement of this chapter.
