SECTION 1. Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt Fletcher's Laundry and Dream Cafe of 748 West 61st Street / 6049 South Halsted Street from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for Premise Address.
