ORDINANCE

STONY ISLAND RECLAMATION COMPANY Acct. No.

88507 - 1 Permit No. 1115226

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to STONY ISLAND RECLAMATION COMPANY, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Force Sewer Main under the public right-of-way adjacent to its premises known as 12123 S. Stony Island Ave..

Said Force Sewer Main at S. Stoney Island Avenue measure(s):

One (1) at four thousand twenty-six (4026) feet in length, and one (1) foot in width for a total of four thousand twenty-six (4026) square feet.

Existing force sewer main span south underneath South Stony Island Avenue, from a point about five (5) feet west of the northeast corner of the intersection of East 122nd Street and South Stony Island Avenue for approximately four thousand twenty-six (4,026) feet to connect with an existing Metropolitan Sanitary District wet well along the north river bank.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1115226 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
