AMENDATORY PUBLIC HEARING ORDINANCE

WHEREAS, by virtue of Section 6(a) of Article VII of the 1970 Constitution of the State of Illinois, the City of Chicago is a home rule unit of local government and as such may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, special service areas may be established pursuant to Article VII, Sections 6(l) and 7(6) of the Constitution of the State of Illinois, and pursuant to the provisions of the Special Service Area Tax Law, 35 ILCS 200/27-5 et seq.. as amended from time to time, and pursuant to the Property Tax Code, 35 ILCS 200/1 -1 et seq., as amended from time to time; and

WHEREAS, on December 7, 2005, the City Council of the City of Chicago (the "City Council") enacted an ordinance which established an area known and designated as City of Chicago Special Service Area Number 34 (the "Original Area") and authorized the levy of an annual tax, for the period beginning in tax year 2005 through and including tax year 2014 (the "Original Period") not to exceed an annual rate of twenty-five hundredths of one percent (0.250%) of the equalized assessed value of the taxable property therein to provide certain special services in and for the Area in addition to the services provided by and to the City of Chicago generally (the "Original Special Services"); and

WHEREAS, on October 8, 2014, the City Council adopted an ordinance which was published in the Journal of Proceedings of the City Council of the City of Chicago for such date, and which authorized a public hearing (the "Public Hearing Ordinance") to consider (i) the enlargement of the boundaries of the Original Area while keeping its designation as City of Chicago Special Service Area Number 34, (ii) the authorization of special services distinct from the Original Special Services, and (iii) the authorization of an extended levy period for the levy of the services tax within the special service area, as enlarged;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1. Incorporation of Recitals. The recitals contained in the preambles to this Amendatory Ordinance are hereby incorporated into this Amendatory Ordinance by this reference.

Section 2. Amendment of Public Hearing Ordinance. The Public Hearing Ordinance is hereby amended by deleting Exhibit 1 in its entirety and replacing such Exhibit 1 with the text of the Exhibit 1 attached to this Amendatory Ordinance and hereby made a part hereof.

Section 3. Separability. If any provision of this Amendatory Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any remaining provisions of this Amendatory Ordinance.

Section 4. Inconsistent Provisions. All ordinances, resolutions, motions or orders in conflict with this Amendatory Ordinance are hereby repealed to the extent of such conflict, provided that the Public Hearing Ordinance, except as amended by this Amendatory Ordinance, shall remain in full force and effect.

Section 5. No Impairment. To the extent that any ordinance, resolution, rule, order or

provision of the Municipal Code of the City of Chicago, or part thereof, is in conflict with the provisions of this Amendatory Ordinance, the provisions of this Amendatory Ordinance shall be controlling.

Section 6. Effective Date. This Amendatory Ordinance shall be in full force and effect immediately upon its passage and approval.
