ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the MI-1, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 11 -K in the area bounded by

West Montrose Avenue; the public alley next east of and parallel to Cicero Avenue; the public alley next south of and parallel to West Montrose Avenue; and a diagonal line commencing 56.90 feet east of the public alley next east of and parallel to Cicero Avenue and extending southeasterly and ending at a point 100.73 feet east of the public alley next east of and parallel to Cicero Avenue,

to those of a C2-3 Motor Vehicle-Related Commercial District. SECTION 2. This ordinance

takes effect after its passage and approval.303
