## **ORDINANCE**


#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M3-3, Heavy Industry District, symbols and indications as shown on Map No. 26-E in the area bounded by

A line 241.15 feet north of and parallel to East 111 Street; South Langley Avenue; a line 100.00 feet north of and parallel to East III<sup>th</sup> Street extending from South Langley Avenue to a point 165.00 feet west thereof then extending south and parallel to South Langley Avenue for a distance of 100.00 feet, then extending west and parallel to East 111<sup>th</sup> Street for a distance of 11.85 feet; and a line 176.85 feet west of and parallel to South Langley Avenue,

to those of a Cl-1, Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.

#### **ZONING AND DEVELOPMENT ANALYSIS**

The subject property, located at 11040 South Langley Avenue, in Chicago, Cook County, Illinois, consists of a parcel of land located on the west side of South Langley Avenue, approximately 150" north of East 111<sup>th</sup> Street. The parcel is bound by a vacant and undeveloped parcel of land to the south and an existing building (11030 S. Langley Ave.) to the north. A parcel of land, occupied by green space and an existing parking lot, is located adjacent to the west ofthe site.

The parcel is currently occupied by an existing one-story brick building, approximately 4,900-SF in size, situated on the northeast corner of the site. The remainder of the site is occupied by an existing asphalt, concrete and gravel lot bound by a chain link fence. The total lot area is approximately 26,150-SF.

Following is a summary of our zoning and development analysis for the above-referenced property:

- Lot Area = 26,150-SF
- Floor Area Ratio = 0.19
- Density (lot area per dwelling unit): not applicable. Site is not a residential development.
- Off-Street Parking: An existing asphalt, concrete and gravel lot, which could likely be used for off-street parking,
