#### **ORDINANCE**

TWO EAST ERIE CONDOMINIUM ASSOCIATION Acct. No.

347858 -1 Permit No. 1116119

### Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to TWO EAST ERIE CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 2 E. Erie St..

#### Said Canopy(s) at E. Erie measure(s):

One (1) at thirty-three point one six (33.16) feet in length, and four (4) feet in width for a total of one hundred thirty-two point six four (132.64) square feet.

#### Said Canopy(s) at E. Erie measure(s):

One (1) at eighteen point six six (18.66) feet in length, and four (4) feet in width for a total of seventy-four point six four (74.64) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1116119 herein granted the sum of one hundred eight dollars and sixteen cents (\$108.16) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
