SECTION 1 That the City Zoning Ordinance be amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No. 11-K in area bound by

NORTH TRIPP AVENUE; WEST IRVING PARK ROAD, AND; THE PUBLIC ALLEY
