ORDINANCE WESTEND BAR & GRILL Acct. No. 311103-1 Permit No. 1116541

## Be It Ordained by the City Council ofthe City of Chicago:

Permission and authority are hereby given and granted to WESTEND BAR & GRILL upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 1326-28 W. Madison St.. Said sidewalk cafe area #1 shall be fifty-one point five (51.5) feet in length and seven (7) feet in width, area #2 shall be twenty-one (21) feet in length and five (5) feet in width, area #3 shall be fourteen point three three (14.33) feet in length and five (5) feet in width for a total of five hundred thirty-seven point one five (537.15) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along Ada Street, and W. Madison Street. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Thursday 11:00 a.m. to 10:00 p.m. Friday 11:00 a.m. to 11:00 p.m. Saturday 11:00 a.m. to 11:00 p.m. Sunday 11:00 a.m. to 10:00 p.m. Compensation: \$600.00 SEATING CAPACITY: 50

Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1116541 for a sidewalk cafe shall be subject to the provisions of Section 10-28-800 though 10-28-885 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
