ORDINANCE

WHITE HOUSE BLACK MARKET Acct. No.

302541 - 5 Permit No. 1115797

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to WHITE HOUSE BLACK MARKET, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Awning(s) projecting over the public right-of-way adjacent to its premises known as 901 W. Weed St..

Said Awning(s) at W Weed St measure(s):

Two (2) at five point four two (5.42) feet in length, and four point five (4.5) feet in width for a total of forty-eight point seven eight (48.78) square feet.

Two (2) at twelve point six seven (12.67) feet in length, and four point five (4.5) feet in width for a total of one hundred fourteen point zero three (114.03) square feet.

One (1) at five point two five (5.25) feet in length, and four point five (4.5) feet in width for a total of twenty-three point six three (23.63) square feet.

One (1) at six point zero eight (6.08) feet in length, and four point five (4.5) feet in width for a total of twenty-seven point three six (27.36) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1115797 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


