Permission and authority are hereby given and granted to THE BODY SHOP INC, upon the terms and S/lir subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over A-vf *ne Public right-of-way adjacent to its premises known as 5820 N. Western Ave..

Said Awning(s) at North Western Avenue measure(s): jv[* One (1) at one hundred (100) feet in length, and two (2) feet in width for a total of two hundred (200) square feet.

fi? The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

;;>VSaid privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department -t§§, Signs.

^II.^his grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1106835 herein granted the sum of one hundred twenty-five (\$125.00) per annum in advance.
