TRAFFIC LANE - TOW/AWAY ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as traffic lane- tow/away zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

• 30 Minute Standing Zone, Unattended Vehicles Must Have Lights Flashing, after 30 Minutes Tow Zone - 6:00 A.M. to 6:00 P.M., Monday thru Friday 10-01767683 (PO2010-5901);
- 17 W. 64th St. (ss) fap 20' east of S. Ashland Ave. tap 35' east thereof
-15 Minute Standing Zone, Unattended Vehicles Must Have Lights Flashing after 15 Minute/Tow Zone, 6:00 A.M. to 8:00 P.M., Monday thru Friday 10-01289450 (PO2010-4958);
- 27 W. Superior St. (ns) fap 35' east of N. Ashland Ave. tap 25' east thereof -15 Minute Standing Zone, Use Flashing Lights, Tow Zone after 15 Minutes, 9:00 A.M. to 6:00 P.M., Monday thru Friday 10-01193940 (PO2010-4506);
- 42 N. Dearborn (es) fap 109' north of W. Oak St. tap 25' north thereof
Tow Zone, At All Times, All Days 10-01564407 (PO2010-5424);
- 42 N. Wells St. (ws) fap 85' north of W. Lake St. tap 25' north thereof,

- Tow Zone, At All Times, All Days 10-01016990 (PO2010-3798);
