BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3, Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 1-H in area bound by

A line 75 feet west of and parallel to North Hoyne Avenue, West Ohio Street, a line 50 feet west of and parallel to North Hoyne Avenue, the alley next south of and parallel to West Ohio Street •

to those of a RM4.5, Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
