BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 That the City Zoning Ordinance be amended by changing all the RT-4 Residential Two-Flat Townhouse and Multi-Unit District symbols and indications as shown on Map No. 6-F in area bound by

WEST 22nd PLACE; A LINE 200 FEET WEST OF AND PARALLEL TO SOUTH WENTWORTH AVENUE; THE ALLEY NEXT SOUTH OF WEST 22ND PLACE, AND; A LINE 225 FEET WEST OF AND PARALLEL TO SOUTH WENTWORTH AVENUE

To those of an B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.

Applicant seeks a Type I Map Amendment of the City of Chicago Zoning Map from the current RT-4 District to that of a B2-3 District for the property commonly known as 221 West 22nd Place. The subject site measures approximately 25 feet in width by 100 feet in depth. This results in a total lot area of 2,500 square feet.

The subject consists of one lot that is improved with a single family home. Applicant seeks to demolish the existing building and improve the site with one building consisting of ground floor business use and two residential dwelling units above the ground floor. The project will provide 3 parking spaces.
