#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Neighborhood Shopping District symbols and indications as shown on Map No. 10-E in area bound by

South Wabash Avenue, a line 225 feet south of and parallel to east 42<sup>nd</sup> Street, the alley next east of and parallel to south Wabash Avenue, a line 250 feet south of and parallel to east 42<sup>nd</sup> Street,

to those of a RS3 Residential Single-Unit (Detached House) District. SECTION 2. This ordinance takes effect after its passage and approval.
