SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Ml-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 5-J in area bound by

A line 175 feet east of and parallel to North Pulaski Road, the alley next north of and parallel to West Dickens Avenue, a line 200 feet east of and parallel to North Pulaski Road, West Dickens Avenue

to those of a RS3 Residential Single-Unit (Detached House) District.


