BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION

1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Cl-2, Neighborhood Commercial District symbols as shown on Map No. 3-1 in the area bounded by:

The public alley next North of and parallel to West Walton Street; a line 389.50 feet West of and parallel to North Sacramento Boulevard; West Walton Street; a line 440.50 feet West of and parallel to North Sacramento Boulevard.

To those of a B2-3, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 18, 2015 the undersigned will file an Application for a change in zoning from Cl-2, Neighborhood Commercial Zoning District to B2-3, Neighborhood Mixed-Use Zoning District on behalf of the Applicant, 3108-3110 W. Walton Condominium Association, Inc. for the property located at 3108-10 West Walton Street, Chicago, Illinois.

The subject property is currendy improved with a three-story multi-unit residential building.
