SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-2 Neighborhood Shopping District symbols and indications as shown on Map No. 11 -H in the area bounded by

the public alley next north of and parallel to West Irving Park Road; a line 47.20 feet east of and parallel to North Damen Avenue, West Irving Park Road; North Damen Avenue;
