SECTION 1. Permission and authority are hereby given and granted to EAST OF THE RYAN.INC, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 914 E . 79th St.

Said sign structure(s) measures as follows; along E 79TH ST:
One (1) at eight (8) feet in length, twelve (12) feet in height and twelve point seven five (12.75) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.
