#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 That the City Zoning Ordinance by amended by changing all the Bl-1 Neighborhood Shopping District symbols and indications as shown on Map No. 15-K in area bound by

LINE 250 **FEET** NORTH OF AND **PARALLEL** TO **WEST ROSEMONT** AVENUE; THE ALLEY NEXT EAST OF NORTH PULASKI ROAD; A LINE 175 PARALLEL FEET NORTH OF AND TO **WEST ROSEMONT** AVENUE, NORTH PULASKI ROAD

To those of an B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.

# ZONING AND DEVELOPMENT NARRATIVE IN SUPPORT OF AN APPLICATION FOR A TYPE I MAP AMENDMENT OF THE CITY OF CHICAGO ZONING MAP FOR THE PROPERTY COMMONLY KNOWN AS 6313-25 NORTH PULASKI ROAD

Applicant seeks a Type I Map Amendment of the City of Chicago Zoning Map from the current Bl-1 District to that of a B2-3 District for the property commonly known as 6313-25 North Pulaski Road. The property consists of two lots. The northern lot measures approximately 25 feet in width and 117 feet in depth resulting in a total lot area of 2,925 square feet. The southern lot measures 50 feet in width by 117 feet in depth for a total lot area of 5,850 square feet.

Applicant seeks to demolish the existing one story commercial buildings. The site will be improved with two residential buildings. One building will contain three residential dwelling units. The other building will contain six residential dwelling units.


