BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the District C1-2 Neighborhood Commercial District and indications as shown on Map No. 2-H in the area bounded by

A line 165.85 feet south of and parallel to West Taylor Street; the north south alley east of and parallel to South Claremont Avenue; a line 190.05 feet south of and parallel to West Taylor Street; South Claremont Avenue

to those of a RT-4 Residential Two-Flat, Townhouse and Multi Unit District SECTION
