ORDINANCE SIMPLY PREPAID Acct. No. 364546 -3 Permit No. 1117540

#### Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SIMPLY PREPAID, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Awning(s) projecting over the public right-of-way adjacent to its premises known as 3619 W. Irving Park Rd..

#### Said Awning(s) at Irving Park Road measure(s):

One (1) at twenty-two point five (22.5) feet in length, and three point zero eight (3.08) feet in width for a total of sixty-nine point three (69.3) square feet.

#### Said Awning(s) at Elston measure(s):

One (1) at twenty-one point zero eight (21.08) feet in length, and three point zero eight (3.08) feet in width for a total of sixty-four point nine three (64.93) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1117540 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
