ORDINANCE AMERICAN GIRL Acct. No. 387336 -1 Permit No. 1118469

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to AMERICAN GIRL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, eight (8) Awning(s) projecting over the public right-of-way adjacent to its premises known as 845 N. Michigan Ave..

Said Awning(s) at E. Chestnut Street measure(s):  
Six (6) at twenty-six point three (26.3) feet in length, and four (4) feet in width for a total of six hundred thirty-one point two (631.2) square feet.

Said Awning(s) at N. Miles Vander Roe measure(s):  
One (1) at twenty-six point two (26.2) feet in length, and seven (7) feet in width for a total of one hundred eighty-three point four (183.4) square feet.

Said Awning(s) at E. Pearson measure(s):  
One (1) at twenty-six point two (26.2) feet in length, and seven (7) feet in width for a total of one hundred eighty-three point four (183.4) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.


Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1118469 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
