#### **ORDINANCE**

STATE FARM INSURANCE DAVID J FREDERICKSON Acct. No.

207289 - 3 Permit No. 1114762

, Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to STATE FARM INSURANCE DAVID J . FREDERICKSON, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Awning(s) projecting over the public right-of-way adjacent to its premises known as 6261-63 N. Clark . St...

Said Awning(s) at N. Clark Street measure(s):

One (1) at twelve point seven five (12.75) feet in length, and two (2) feet in width for a total of twenty-five point five (25.5) square feet.

One (1) at twelve point eight three (12.83) feet in length, and two (2) feet in width for a total of twenty-five point six six (25.66) square feet.

One (1) at five point six six (5.66) feet in length, and two (2) feet in width for a total of eleven point three two (11.32) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and . Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1114762 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

, Jhe permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs . associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
