ORDINANCE MAC WEST  
LLC Acct. No. 396115-1  
Permit No. 1116786

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to MAC WEST LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use sixteen (16) Caisson(s) under the public right-of-way adjacent to its premises known as 167 W. Erie St..

Said Caisson(s) at W. ERIE ST measure(s):

Three (3) at six point seven five (6.75) feet in length, and two point five (2.5) feet in width for a total of fifty point six three (50.63) square feet.

Said Caisson(s) at N. WELLS ST measure(s):

One (1) at thirteen point seven five (13.75) feet in length, and two point five eight (2.58) feet in width for a total of thirty-five point four eight (35.48) square feet.

Ten (10) at six point seven five (6.75) feet in length, and two point five eight (2.58) feet in width for a total of one hundred seventy-four point one five (174.15) square feet.

Said Caisson(s) at W ONTARIO ST measure(s):

One (1) at six point eight three (6.83) feet in length, and two point eight three (2.83) feet in width for a total of nineteen point three three (19.33) square feet.

(pne (1) at six point eight three (6.83) feet in length, and two point eight three (2.83) feet in width for a total of nineteen point three three (19.33) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1116786 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
