SUBDIVISION ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. Chicago Department of Transportation, the Commissioner or any of her designees, are hereby authorized and directed to approve a proposed East-West University Subdivision being a vertical subdivision in the block bounded E. 8th Street, E. 9th Street, S. Wabash Avenue and S. Michigan Avenue, and legally described in the attached plat (Exhibit A, File CDOT: 15-02-14-3672) which, for greater certainty, is hereby made a part ofthis ordinance.

SECTION 2. The subdivision herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, East-West University Inc., a Wisconsin not for profit corporation, licensed to transact business in Illinois, or its agent shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the full sized corresponding Plat approved by the Chicago Department of Transportation's Superintendent of Maps and Plats.

SECTION 3. This ordinance and exhibit subdivision plat shall take effect and be in force from and after their recording.
