ORDINANCE

O'DONNELL INVESTMENT CO. Acct. No.

390607 - 1 Permit No. 1113273

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to O'DONNELL INVESTMENT CO., upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Sanitary Sewer Strom Line to be installed underneath the raised alley structure and will continue underneath West Lake Street where it will connect into an existing fifteen (15) inch sanitary sewer adjacent to its premises known as 150 N. Riverside Plaza..

Said Sewer(s) at W. Lake Street measure(s):

One (1) atone hundred eleven (111) feet in length, and one (1) foot in width for a total of one hundred eleven (111) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1113273 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
