#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District symbols as shown on Map No.  $\_?\sim^1$  in the area bounded by:

West Fullerton Avenue; a line 54.50 feet East of and parallel to North Talman Avenue; the public alley next South of and parallel to West Fullerton Avenue; North Talman Avenue.

To those of a B2-2, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and approval.
