ORDINANCE LUGANO'S
PIZZA Acct. No. 6607 - 2
Permit No. 1119629

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LUGANO'S PIZZA, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 4460 S. Kedzie Ave..

Said Canopy(s) at S. KEDZIE AVE measure(s):

One (1) at twelve point seven five (12.75) feet in length, and five (5) feet in width for a total of sixty-three point seven five (63.75) square feet.

Said Canopy(s) at W. 45TH ST measure(s):

One (1) at eight point eight three (8.83) feet in length, and five (5) feet in width for a total of forty-four point one five (44.15) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1119629 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
