ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all B1 -2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-G in the area bounded by

A line 82.02 feet north of and parallel to West Dakin Street; North Sheridan Road; West Dakin Street; a line 125 feet west of and parallel to North Sheridan Road

to those of B3-5 Community Shopping District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.






