### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 6-F in the area bounded by:

The public alley next North of and parallel to West 22<sup>nd</sup> Place; a line 250.48 feet East of and parallel to South Princeton Avenue; West 22<sup>nd</sup> Place; a line 100 feet East of and parallel to South Princeton Avenue.

To those of an RM6.5, Residential Multi-Unit District

**SECTION 2. This Ordinance takes effect after its passage and approval.**
