RESOLUTION FOR RENEWAL OF CLASS 6(B) REAL ESTATE TAX INCENTIVE FOR THE BENEFIT OF RAFFIN PROPERTIES, INC., AN ILLINOIS CORPORATION, AND REAL ESTATE LOCATED GENERALLY AT 736 EAST 112TM STREET IN CHICAGO, ILLINOIS PURSUANT TO COOK COUNTY, ILLINOIS REAL PROPERTY ASSESSMENT CLASSIFICATION ORDINANCE

WHEREAS, the Cook County Board of Commissioners has enacted the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Ordinance"), which provides for, among other things, real estate tax incentives to property owners who build, rehabilitate, enhance and occupy property which is located within Cook County and which is used primarily for industrial purposes; and

WHEREAS, the City of Chicago (the "City"), consistent with the Ordinance, wishes to induce industry to locate, expand and remain in the City by supporting financial incentives in the form of property tax relief; and

WHEREAS, Raffin Properties, Inc., an Illinois corporation (the "Applicant"), is the owner of certain real estate located generally at 736 East 112th Street, Chicago, Illinois 60628 as further described on Exhibit A hereto (the "Subject Property"); and

WHEREAS, on November 2, 1994 the City Council of the City enacted a resolution supporting and consenting to the Class 6(b) classification of the Subject Property along with certain additional property (together, the "Original Property") by the Office of the Assessor of Cook County (the "Assessor"); and

WHEREAS, the Assessor granted the Class 6(b) tax incentive in connection with the Original Property in 1995; and

WHEREAS, on November 13, 2002 the City Council of the City enacted a resolution supporting and consenting to the renewal of the Class 6(b) classification of the Original Property by the Assessor; and

WHEREAS, the Assessor granted the renewal of the Class 6(b) tax incentive in connection with the Original Property in 2003; and

WHEREAS, after the acquisition of the Original Property by the Applicant in 2007, an assessment division was done with respect to the Original Property for Permanent Index Number 25-23-102-006-0000, and the Subject Property was assigned Permanent Index Number 25-23-102-009-0000; and

WHEREAS, the Subject Property is currently leased by the Applicant to Comcast of Illinois/Texas, Inc.; and

WHEREAS, the Applicant has filed an application for renewal of the Class 6(b) classification with the Assessor with respect to the Subject Property pursuant to the Ordinance; and

WHEREAS, it is the responsibility of the Assessor to determine that an application for a Class 6(b) classification or renewal of a Class 6(b) classification is eligible pursuant to the Ordinance; and

WHEREAS, the Ordinance requires that, in connection with the filing of a Class 6(b) renewal application with the Assessor, an applicant must obtain from the municipality in which such real estate is located a resolution expressly stating that the municipality has determined that the industrial use of the property is necessary and beneficial to the local economy and that the municipality supports and consents to the renewal of the Class 6(b) classification; now therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: That the City determines that the industrial use of the Subject Property is necessary and beneficial to the local economy in which the Subject Property is located.

SECTION 2: That the City supports and consents to the renewal of the Class 6(b) classification with respect to the Subject Property.

SECTION 3: That this shall be the final renewal of the Class 6(b) classification to which the City shall support and consent with respect to the Subject Property while such Subject Property is utilized primarily as a parking lot.

SECTION 4: That the Clerk of the City of Chicago is authorized to and shall send a certified copy of this resolution to the Office of the Cook County Assessor, Room 312, County Building, Chicago, Illinois 60602 and a certified copy of this resolution may be included with the Class 6(b) renewal application filed with the Assessor by the Applicant, as applicant, in accordance with the Ordinance.

SECTION 5: That this resolution shall be effective immediately upon its passage and approval.
