
THE UNIVERSITY OF CHICAGO (File #19) Acct. No.

Be It Ordained by the City Council of the City of Chicago:

Existing Steam Tunnel(s) at E. 60th Street measure(s):

Existing steam tunnel consist of a six (6) inch extra heavy steam main and a three (3) inch wrought iron return main encased in an insulated conduit, beginning at an existing manhole located on private property at a point thirty-seven (37) feet ten (10) inches south of the south curb line of East 60th Street; thence under and across South Ingleside Avenue at a point approximately thirty-three (33) feet eight (8) inches south of the south curb line of East 60th Street, terminating in a concrete manhole located under the public sidewalk on the west side of South Ingleside Avenue. Also, to maintain and use as now installed a steam main and return main, both encased in insulated conduit, under and across South Drexel Avenue at a point approximately thirty-one (31) feet south of the south curb line of East 60th .iStreet and South Ingleside Avenue; thence proceeding southward and west of west sidewalk of South Drexel Avenue . into private property; thence under and across the public alley south of East 60th Street at a point approximately fifty-* three (53) feet ten (10) inches west of the west curb line of South Drexel Avenue and terminating inside the building located at 6022-6024 South Drexel Avenue.



The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

, This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

;,The grantee shall pay to the City of Chicago as compensation for the privilege #1118262 herein granted the sum of none thousand two hundred (\$1,200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) yeare from and after 09/29/2014.
