Said sign structure(s) measures as follows; along North Harlem Avenue:
One (1) at eight point two five (8.25) feet in length, two point zero eight (2.08) feet in height and ten point five (10.5) feet above grade level.
One (1) at nine point five (9.5) feet in length, six point five eight (6.58) feet in height and fifteen point nine two (15.92) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.
