ORDINANCE 3FLTH IV LLC
Holdings 3 Acct. No. 401002 -1
Permit No. 1120124

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 3FLTH IV LLC Holdings 3, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Fence(s) on the public right-of-way adjacent to its premises known as 1641 W. 21st St..

' Said Fence(s) at W. 21st Street measure(s):

One (1) at twenty-seven point three three (27.33) feet in length, and one (1) foot in width for a total of twenty-seven point three three (27.33) square feet. Existing fence is approximately five (5) feet six (6) inches in height.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1120124 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

Authority herein given and granted for a period of five (5) years from and after T-Jate of Passage.

associated with damage, relocation or removal of private property caused by, the City performing work in the public way. //
