SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, be amended by changing the RS-3, Residential Single-Unit District designation as shown on Map Number 1-1 in the area bounded by:

Superior Street, a line located 340.81 feet west of the western right-of-way of Rockwell Avenue extending south to the first alley south of Superior Street; a line located 365.81 feet west of western right-of-way of Rockwell Avenue extending north to Superior Street.

To RT -4, Residential Two-Flat, Townhouse and Multi-Unit District.
