BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-5 Community Shopping District symbols and indications as shown on Map No. 13-G in the area bounded by:

North Broadway; West Gunnison Street; the public alley next west of and parallel to, North Broadway; a northeasterly line perpendicular to the public alley next west of and parallel to North Broadway 121.44 feet south of center line of West Gunnison Street (as measured along the east boundary line of the public alley next west of and parallel to North Broadway ),

to those of C1-5 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about October 6, 2015 the undersigned attorney will file an application for a change in zoning from B3-5 Community Shopping District to C1-5 Neighborhood Commercial District on behalf of the Applicant, Flynn Industries, LLC, for the property located at 4830 N. Broadway, Chicago, Illinois 60640 and bounded by:

North Broadway; West Gunnison Street; the public alley next west of and parallel to.
